Internships

PCED/Nex-Gen providing 12 internships within Phillips County this summer. Applications for interns now available and being promoted within area schools.

Commissioners not in favor of PCED owning property for renovation/rehabilitation. Approached the Phillipsburg City Council to postpone the proposed demolition based on four interested, independent entities looking at property for a rehabilitation project. Was given until March 5th (4 weeks) to find a solution and then to approach the City Council again with details. Still looking at alternatives in case the current four decide against the project.

Commissioners signed new resolution for 2018 funding. Conducting a Phillips County participant survey to determine benefit analysis for legislative testimony.
